1. Purpose. To publish a local policy regarding priority
assignment to family housing for key and essential personnel.

2. Cancellation. MCIEAST-MCB CAMLEJBul 11101 of 1 Mar 2016.

3. Background. Per the reference, military necessity takes
precedence over all other considerations in priority of
assignment to family housing. There are seven General Officer
billets aboard MCB CAMLEJ that are designated as "key and
essential" for priority of assignment purposes to family
housing. Additionally, the following list of Colonel/Navy
Captain (O-6) and Sergeants Major billets are also designated as
key and essential:


- a. Commanding Officer, Marine Corps Air Station, New River
- b. Commanding Officer, Naval Hospital
- c. Deputy Commander, Marine Corps Installations East-Marine
Corps Base, Camp Lejeune (MCIEAST-MCB CAMLEJ)
- d. Deputy Commander, U. S. Marine Corps Forces, Special
Operations Command (MARSOC)
- e. Chief of Staff, MARSOC
- f. Chief of Staff, II Marine Expeditionary Force

- g. Chief of Staff, MCIEAST-MCB CAMLEJ
- h. Chief of Staff, 2d Marine Expeditionary Brigade

- k. Sergeant Major, MCIEAST-MCB CAMLEJ

4. Action. Married personnel serving on accompanied tours in the above listed billets will be assigned to available housing upon arrival or placed in a position of priority on the waiting list. However, other applicants already given a firm housing commitment will not be displaced.

5. Reserve Applicability. This Bulletin is applicable to MCB CAMLEJ and all tenant organizations and is effective the date signed.
