1. Situation. A permanent IMFPC is established to improve supporting personnel and family readiness agencies, programs, and services through facilitated communication between the U.S. Marine Corps Enterprise and Marine Corps Installations East-Marine Corps Base, Camp Lejeune (MCIEAST-MCB CAMLEJ) stakeholders.
2. Cancellation. MCIEAST-MCB CAMLEJO 1754.5.
3. Mission. The IMFPC strives to foster growth and enhance resiliency in Marines, Sailors, and family members through appropriate actions; implementing changes and communication with programs impacting personal and family readiness both locally and across the U.S. Marine Corps Enterprise; and addressing the standards of the military lifestyle.
4. Execution
 - a. Commander's Intent. The IMFPC will review family readiness policies, strategic plans and resources, and identify family readiness and Single Marine Program concerns or issues that cannot be resolved at the command level. Issues that cannot be resolved by the IMFPC will be submitted to the Marine and Family Programs Committee (MFPC).
 - b. Concept of Operations. Topics covered by the IMFPC during its meetings will typically include, but not be limited to, effectiveness of family readiness programs, communication tools, Single Marine Program, and funding of services and programs vital to optimal family readiness.

5. Administration and Logistics

a. IMFPC meetings will be held quarterly in January, April, July, and October. The meeting agenda will be coordinated between the Chair; Assistant Chief of Staff (AC/S), Marine Corps Community Services (MCCS), MCIEAST-MCB CAMLEJ; and the Installation Family Readiness Program Manager. Members have the right to submit action items that will be added to the agenda as appropriate.

b. Eight voting members, or their designated representatives, constitute a quorum and are empowered to act for the Council. The Chair may accept the proxy vote of absent principals if a quorum is present at the meeting.


c. The Chair may establish subcommittees as required. Minutes of council meetings will be recorded and published two weeks following each meeting.

d. The IMFPC will report to the MFPC.
