- 1. Situation. References (a) and (b) require that any U&FRF remaining unexecuted, or in excess, at the end of the Nonappropriated Fund (NAF) Fiscal Year (FY) be withdrawn from that commanders' account unless the Installation commander authorizes a waiver. Therefore, the Commanding General (CG), Marine Corps Installations East-Marine Corps Base, Camp Lejeune (MCIEAST-MCB CAMLEJ) will withdraw all unexecuted U&FRF annually at the end of each NAF FY on or about 31 January. Headquarters Marine Corps directed a reduction in U&FRF of 25 percent beginning 1 February 2017 and another cumulative 25 percent reduction beginning 1 February 2018, for a total reduction of 50 percent. This reduction necessitates the utmost prudence in the use of U&FRF and, where necessary, recovery of any unexecuted U&FRF. While requests for waivers will be considered only in exceptional circumstances, commanders may submit a waiver of this requirement to the CG, MCIEAST-MCB CAMLEJ using enclosure (1). The request must contain a detailed justification for waiving the requirement to withdraw the unexecuted or excess U&FRF.
- 2. Cancellation. MCIEAST-MCB CAMLEJO 7010.2A.
- 3. <u>Mission</u>. This Order publishes the procedure for requesting a waiver of the requirement in references (a) and (b) that the CG, MCIEAST-MCB CAMLEJ withdraw any unexecuted or excess U&FRF at the end of each NAF FY.

# 4. Execution

- a. Commander's Intent and Concept of Operations
- (1) <u>Commander's Intent</u>. To ensure commanders execute the Commandant of the Marine Corps' intent that units maximized the use of

U&FRF for the benefit of Marines and their families during the NAF FY in which the funds are allocated.

- (2) <u>Concept of Operations</u>. U&FRF are allocated according to the process detailed in reference (a). Unexecuted U&FRF will be withdrawn in accordance with references (a) and (b).
- b. <u>Coordinating Instructions</u>. Commanders, or their designated representatives, receive a monthly notice from the Assistant Chief of Staff (AC/S), Marine Corps Community Services (MCCS), MCIEAST-MCB CAMLEJ detailing the amount of U&FRF remaining in their accounts. Balances may be confirmed at any time by contacting the Deputy Chief Financial Officer, MCCS, Lejeune-New River at (910) 449-8944.
  - c. Tasks. The AC/S, MCCS, MCIEAST-MCB CAMLEJ:
- (1) Allocate U&FRF each quarter of the NAF FY as detailed in reference (a).
- (2) Distribute a monthly balance report to all commanders and their designated representatives.
- (3) Assist commanders and their designated representatives with the proper expenditure of U&FRF as defined in reference (a).
- 5. Administration and Logistics. Commanders that can justify a waiver to retain unexecuted U&FRF past the end of the NAF FY will submit enclosure (1) to the CG, MCIEAST-MCB CAMLEJ no later than 1600 on the second Friday of each January with an advance courtesy copy forwarded to the Deputy Chief Financial Officer, MCCS, Lejeune-New River, located in Building 895 on Molly Pitcher Road.

# 6. Command and Signal

- a. <u>Command</u>. This Order is applicable to MCB CAMLEJ; Marine Corps Air Station, New River; their subordinate commands; and all tenant organizations aboard both installations.
  - b. Signal. This Order is effective the date signed.
