- b. $\underline{\text{Tasks}}$. Per reference (c) all General and Special Staff Departments and those MCIEAST-MCB CAMLEJ Directives that fall under the cognizance of H&S Bn shall:
- (1) Review currency of the Orders, Bulletins, Policy Letters listed in this Bulletin.
- (2) Review to ensure all current directives you sponsor are listed in this Bulletin.
