Subj: UPDATED MASK GUIDELINES FOR VACCINATED PERSONNEL ABOARD MARINE

CORPS INSTALLATION EAST INSTALLATIONS

- 1. <u>Purpose</u>. To promulgate updated policy regarding the wearing of masks aboard Marine Corps Installations East (MCIEAST) installations.
- 2. <u>Scope</u>. This policy applies to the entire MCIEAST community (all those working, living or otherwise visiting MCIEAST installations for any purpose).

## 3. Information

- a. If you are not fully vaccinated, you must wear a mask. In support of updated Center for Disease Control and Prevention guidelines released, subject to applicable labor relations obligations, fully vaccinated Department of Defense (DoD) personnel (who are at least two weeks beyond their final dose) are no longer required to wear masks indoors or outdoors at MCIEAST facilities. Unvaccinated personnel are required to follow applicable DoD mask guidance, including continuing to wear masks indoors.
  - b. The following exceptions and qualifications apply:
- (1) There are no changes to current protocol at Department of Defense Education Activity School facilities.
- (2) There are no changes to current protocol at Marine Corps Community Services Child Development Centers and school age childcare programs housed in the Tarawa Terrace and Stone Street Youth Pavilions.
- (3) There are no changes to current protocol at Medical Treatment and Dental Facilities.
- (4) Uniformed personnel are subject to vaccine verification when entering MCIEAST facilities.

- (5) All other members of the MCIEAST community are expected, on their personal honor, to comply with the elements of this policy.
- 4. Action. All MCIEAST components and tenant commands, and the directors of all on base government and commercial activities are to observe and promote compliance with the measures detained in this policy.
