1. <u>Situation</u>. To ensure protection of the land and wildlife resources aboard Marine Corps Base Camp Lejeune (MCB CAMLEJ) and Marine Corps Air Station New River (MCAS NR) (collectively referred to as the "Installation"), this Order establishes policy and regulations as outlined in the references and the enclosure. The enclosure provides specific details of base procedures for hunting, fishing, trapping, boat launching, and firewood collection.

DISTRIBUTION STATEMENT A: Approved for public release distribution is unlimited.

2. Cancellation. MCIEAST-MCB CAMLEJO 5090.115.

3. Mission

a. This Order provides policy and procedures to ensure compliance with regulations and establishes responsibilities which govern hunting, trapping, scouting, dog training, firewood collection, fishing, and boat launching on the Installation, in an effort to provide conservation of land and wildlife resources.

b. <u>Summary of Revision</u>. This Order has been revised in its entirety to comply with Federal and state regulations and laws, and should be thoroughly reviewed.

4. Execution

a. <u>Commander's Intent</u>. Hunting, fishing, and trapping shall be in compliance with this Order and all other applicable Federal, state, and local laws and regulations.

b. <u>Concept of Operations</u>. This Order fully adopts those regulations and procedures required in the implementation of Federal and state regulations and implements local applicable provisions relating to the recreational use identified herein. Annual bag limits and seasons shall be in compliance with state and Federal regulations, unless otherwise noted in enclosure (1).

5. Administration and Logistics

a. This Order falls under the cognizance of the Commanding General (CG), Marine Corps Installations East (MCIEAST)-MCB CAMLEJ, and can be modified and waived as the CG deems necessary and appropriate to support requirements as they develop. Any significant recommended changes should be presented to the Assistant Chief of Staff (AC/S), G-F Department.

b. The MCB CAMLEJ Conservation Law Enforcement Officer (CLEO) Section, Environmental Conservation Branch (ECON), Environmental Management Division (EMD), AC/S G-F is charged, through the section's immediate supervisor, with the enforcement of fish, wildlife, and natural resource conservation regulations and to request assistance and work effectively and harmoniously with state and Federal personnel. CLEOs shall enforce all regulations related to the directives, enclosures, and references of this Order. The MCB CAMLEJ CLEO and MCAS NR CLEO shall provide technical guidance to each other on enforcement and accident investigation as requested.

c. The MCB CAMLEJ Land and Wildlife Resources Section (LWRS), ECON, EMD, G-F is charged, through the section's immediate supervisor, to develop standing operating procedures (SOP) for implementing a recreational program involving hunting, fishing, trapping, and

boating; to determine when annual changes to the enclosure must be made to be in compliance with Federal and state regulations; and to make program level decisions to responsibly manage land and wildlife resources aboard the Installation.

d. ECON is charged with administering the fish, game and non-game management programs aboard the Installation and to approve annual changes to the enclosure. Personnel notification of annual program changes will be distributed through all available and reasonable channels.

e. <u>Training</u>. All personnel and civilian guests who wish to participate in hunting on the Installation must first satisfy all requirements concerning hunter safety competency prior to issuance of a MCB CAMLEJ hunting permit. Visit http://ncwildlife.org/Hunting/Before-the-Hunt/Hunter-Education-Courses for information on available courses.

f. <u>Punitive Effect</u>. This Order's prohibitions and conduct identified in the enclosure is punitive and those who violate this Order may be subject to adverse administrative or judicial action. Violations of this order may be prosecuted under Article 92 of the Uniform Code of Military Justice or referred to the Special Assistant U.S. Attorney (SAUSA) for prosecution in Federal court as appropriate. In addition, violations of this Order may result in the revocation of hunting, trapping, fishing, or other outdoor recreation privileges.

6. Command and Signal

a. <u>Command</u>. This Order is applicable to MCB CAMLEJ, MCAS NR, and all subordinate and tenant commands aboard these installations.

b. <u>Signal</u>. This Order is effective the date signed.

<u>Title</u>: 9.115 Environmental Standard Operating Procedures (ESOP) for Outdoor Recreation Aboard Marine Corps Base Camp Lejeune and Marine Corps Air Station New River

Related: MCIEAST-MCB CAMLEJO 5090.115A

<u>Purpose</u>: This ESOP establishes the procedures for the implementation and enforcement of the outdoor recreation (to include; hunting, trapping, scouting, dog training, firewood collection, fishing, and boat launching) program for Marine Corps Base Camp Lejeune (MCB CAMLEJ) and Marine Corps Air Station New River (MCAS NR) (collectively referred to as "the installation"). Ensure this ESOP is included in the unit's environmental SOP binder.

Applicability: This ESOP applies to all individuals and organizations aboard the Installation.

<u>Responsibility</u>: All personnel and civilian guests who participate in activities regulated by this Order and this enclosure are responsible for complying with this ESOP.

Procedure:

1. <u>Regulations Violations</u>

a. The rules and regulations contained in this ESOP are enforceable pursuant to the references. Reference (q) may be viewed at: <u>http://www.ncwildlife.org</u> or obtained in hard copy from the Conservation Law Enforcement office. In addition to penalties that may be levied under applicable Federal and state laws and regulations, the Installation commander has inherent administrative authority to revoke outdoor recreation privileges.

2. Accessing the Installation

a. Entering any closed or restricted area for recreational purposes is prohibited.

b. <u>Permit Requirement</u>. All individuals entering installation property for recreational purposes must possess a valid permit for the activity in which they will participate.

c. <u>Authorized Personnel</u>. The following persons are authorized to conduct recreational activities identified in this booklet:

(1) All active duty, retired, and active duty reserve military personnel (authorized to sponsor guests).

(2) Civilian employees (authorized to sponsor guests).

(3) Reservists not on active duty.

(4) Dependents of military personnel (active, retired, reservists) and civilian employees.

(5) Sponsored guests when accompanied by licensed personnel.

3. <u>Vetting and Guest Policy</u>

a. Non-affiliated guests who wish to participate in sanctioned recreational opportunities must have an authorized sponsor and get access approval through the installation security office per current Force Protection requirements.

b. Guest participation in any activity (including individual and organized hunting) will be limited to two per authorized sponsor per occurrence.

c. Sponsors are responsible for the conduct, safety, and supervision of their guests while conducting activities on the Installation.

d. Guests must check-in and must remain in the same training area as their sponsor for all recreational activities.

e. Sponsors are accountable for verifying that each person sponsored has been properly vetted and issued a current permit prior to check-in.

f. When sponsored or dependent persons have their licenses suspended or revoked, the sponsors' licenses can be similarly suspended or revoked when negligent, unsupervised, contributory, instructional, or other culpable action by the sponsor can be shown.

g. Spousal dependents of deployed active duty members may petition the Chief Conservation Law Enforcement Officer (CLEO) for limited variance in sponsoring requirements.

4. Access for Hunting. See section on "Hunting Regulations" for additional information.

a. The Installation is divided into gun hunting areas and archery (bow-only) hunting areas.

b. The Installation commander may designate new hunting areas or change hunting area boundaries by approving a new hunting area map. Changes will become effective when the map is published (Figure 1).

c. The number of hunters allowed in each training area shall be determined by the MCB CAMLEJ CLEOS for MCB CAMLEJ and MCAS NR CLEOS for MCAS NR in coordination with MCB CAMLEJ Land and Wildlife Resources Section.

d. Hunters may request a key, from the MCB CAMLEJ CLEO, in order to access some gated hunting areas. Key borrowing procedures will be explained at the time of issuance and can be rescinded by MCB CAMLEJ CLEO at their discretion or in accordance with force protection conditions. A Security and Key Agreement is required (Figure 2).

5. Access for Fishing

a. Fishing is authorized in managed fish ponds, creeks and streams, Onslow Beach, and other water bodies entirely or partially within installation property. Fishing within training areas is contingent on training requirements. See section on "Fishing Regulations" for additional information.

6. Access for Trapping

a. Trapping is authorized in areas identified as hunting areas, when hunting seasons are closed and contingent on training requirements. See section on "Trapping" for additional information.

b. Trapping is prohibited in hunting areas 24 hours prior to and during organized deer hunts and trappers are not permitted to enter areas reserved for organized hunts on the day of the hunt. Trappers are required to unset traps the night prior to organized deer hunts.

c. Trapping is not be permitted in training areas when such areas are being used for live-firing exercises.

d. Trapping is not permitted within 100 yards of any residential area, adjacent to any school, within impact areas, or within any live-firing areas.

7. <u>Access for Firewood Collection</u>. Firewood collection is authorized in areas identified as hunting areas, during daylight hours, contingent on training requirements. Commercial timber harvest (logging) areas are off-limits for firewood collection until completion of the timber sale contract, at which time the site becomes an authorized firewood area. See section on "Firewood Collection" for additional information.

8. Access for Scouting. Scouting is authorized in areas identified as hunting areas, during daylight hours, when hunting seasons are closed and contingent on training requirements. See section on "Scouting" for additional information.

9. <u>Access for Dog Training</u>. Dog training is authorized in areas identified as hunting areas, contingent on training requirements. See section on "Dog Possession and Use" for additional information.

10. <u>Avenza App (Hunting/Fishing Map)</u>. A PDF version of the Installation Hunting and Fishing Map is available for the iPhone, iPad and Android devices through Avenza. The Avenza web map app allows users to navigate PDF files; it will show your changing positions on the Camp Lejeune Hunting and Fishing Map and allows you to manage waypoints. The map and instructions on how to obtain the Avenza App is available via the internet at: https://wwwl.mcieast.usmc.mil/EFAWCTS. The installation does not

endorse the Avenza app and users assume all risk/liability associated with its use.

11. <u>Area Availability and Coordination</u>. Available areas for outdoor recreational activities shall be assigned per existing training requirements. Training takes precedent over all activities regulated by this ESOP. MCB CAMLEJ Range Control and MCAS NR I&E are responsible for determining area availability located within the boundaries of training areas and live-fire ranges on MCB CAMLEJ and MCAS NR, respectively.

a. <u>Recreation Sheet</u>. The MCB CAMLEJ CLEO shall receive from the Range Control Scheduling Office the Hunting Danger Areas Notice "Rec Sheet," which designates the training areas available the next day. Changes will not be made to available training areas by the Range Control Officer after the Rec Sheet has been issued to the MCB CAMLEJ CLEO unless there are unforeseen, extraordinary training requirements.

b. Large scale activity coordination. Certain large-scale activities are required to be scheduled before occupying a training area and will cause closure of training area that would otherwise be open.

(1) When scheduled activities cause closure of a training area, the Chief CLEO, if authorizing access in that area, shall develop a plan to de-conflict both activities in the training sector.

(2) In no case shall hunting take place within 0.3 miles of the scheduled activity. It shall be incumbent upon the hunter to ensure that he/she remains a minimum of 0.3 miles from the activity.

(3) This authorization does not obligate the Chief CLEO to open an area.

c. <u>Electronic Conservation Tracking System</u>. Electronic Conservation Tracking System is a web-based system used for tracking recreational activities on the installation (e.g., setting up

accounts, obtaining permits, checking in, checking out, harvest reporting, etc.). Access to this system is available via http:/www.lejeune.usmc.mil/gwarden/ from personal computers, smartphones, or at any of the three installation check stations (Common Access Card holders only). A recording at (910) 451-3794 is updated daily with area availability information for outdoor recreation.

(1) Using the electronic tracking system is required for check-in, check-out, and harvest reporting on the Installation.

(2) Utilizing the current alternative process to check in/out and report harvest is required when the electronic system is not operational/accessible.

(3) Training on tracking and reporting requirements will be provided by the MCB CAMLEJ CLEOs during issuance of permits.

(4) An area pass must be displayed on the vehicle's dashboard while participating in recreational activities.

(5) Hard copy report cards must be stamped with date and time when checking out and in and be filled out completely (i.e., full name, permit number, harvest information, etc.).

12. Motorized Vehicle Regulations

a. <u>Vehicle Operation</u>. Additional regulations are listed in references (i) and (j).

(1) Maximum speed on unpaved roads is 25 miles per hour.

(2) Driving in wildlife clearings (food plots) is prohibited.

(3) Driving into or on any impact area, buffer area, surface danger area, live-firing area, security area, barricaded road, or roads or areas with signs prohibiting vehicular travel is prohibited.

b. Accident Reporting. When a vehicle accident involving wildlife occurs, the traffic investigator should notify the installation CLEO. All wildlife species accidentally killed by motor vehicles, privately owned vehicle (POV), or government vehicle shall be surrendered by the operator to the installation CLEO or their representative for disposition per Federal and state regulations. NOTE: Custody of white-tailed deer killed in a collision with a POV may be transferred to the operator, upon their request, if the installation CLEO provides them a written permit authorizing them to own and transport the carcass.

c. <u>Prohibited Vehicles</u>. Non-registered off-road vehicles (including, but not limited to all-terrain vehicles (ATVs),; motorcycles (for off-road use), dune buggies, golf carts, and gokarts) are not authorized for use aboard the Installation, except when in use for official government actions.

d. Roadways, gates, ramps, or any access route will not be blocked. Parking and leaving any motor vehicle or conveyance in a manner that impedes law enforcement or emergency vehicles is unlawful.

13. Licensing and Permits. All persons authorized to hunt, fish, and trap will have in their possession a proper and valid North Carolina (NC) state issued hunting, fishing, or trapping license pursuant to the NC regulations found in references (n), (o), and (q). This includes valid big game harvest tags and migratory bird stamp if hunting those species. All persons while hunting, fishing, and/or trapping will display proper licenses and permits at the request of any person authorized to enforce laws and regulations.

a. <u>Installation Permit Types</u>. All permit fees are nonrefundable and non-transferable. Permits fees are subject to change.

(1) Seasonal Combination Hunting and Fishing Permits (\$20.00): expires one year from date of issue.

(2) Daily Hunting and/or Fishing Permits (\$5.00): Valid for one day as noted on permit.

(3) Seasonal Hunting Permits (\$15.00): expires one year from date of issue.

(4) Seasonal Fishing Permits (\$10.00): expires one year from date of issue.

(5) Minor Dependents' (dependents aged 13 to 16) Hunting Permits (Free): expires one year from date of issue.

(6) Trapping Permits (\$25.00): expires one year from date of issue.

(7) Seasonal Wood Collection Permit (\$10.00): must be over 18 years of age; expires one year from date of issue.

(8) Seasonal Boat Launch Permit (Free): expires one year from date of issue.

(9) Beach Driving Permit (Free): expires one year from date of issue.

b. Installation Permit Restrictions

(1) Permit applicants must first satisfy all requirements concerning hunter safety competency prior to issuance of an installation hunting permit.

(2) All persons 13 years of age and older must apply to the MCB CAMLEJ CLEO for an installation hunting or trapping permit. Unlicensed persons 13 years of age and over will not be allowed access to hunting areas.

(3) Persons 13 through 15 years of age will be allowed to hunt when under immediate control and adjacent to their licensed parent or guardian.

(4) Persons under 13 years of age will not be allowed to hunt or trap, but may accompany their parents or guardians provided parents or guardians have submitted the appropriate waivers.

(5) Authorized persons under 16 years of age may fish without a permit or NC fishing license provided the parent or legal guardian has executed appropriate waivers.

c. Installation Permit Issuance. The MCB CAMLEJ CLEO office will determine and/or accomplish the following tasks prior to issuing permits:

(1) That the applicant is eligible and possesses appropriate licenses and identification.

(2) That all applicants execute the appropriate certificates and waivers (Figures 3-5). The documents will be retained on file by the MCB CAMLEJ CLEO.

(3) That all applicants are familiar with current Federal, state, county, and MCB CAMLEJ hunting, fishing, and trapping laws and regulations.

(4) The MCB CAMLEJ CLEO will issue permits upon validation of receipt of permit payment.

14. <u>General Regulations</u>. All local, state, and Federal laws and regulations apply to installation property, unless specifically modified by this rules and regulation product.

a. Destruction, injury, defacement, disturbance, or removal of any government property on the installation is prohibited.

b. All permanent structures aboard the Installation (e.g., towers, buildings, concrete bunkers, trenches, etc.) are off limits. Exception: head facilities/restrooms may be used if available.

c. The feeding, removal, importing, destruction, harassment, injury, or killing of any wildlife aboard the installation, including all species of snake, is prohibited except as specifically authorized by state and Federal permits issued to authorized installation personnel. All species of animals seized or surrendered to the Installation CLEO will be disposed of pursuant to current state and Federal regulations.

d. Possession of live, wounded, or otherwise disabled wildlife is unlawful; only carcasses may be possessed and transported. Report injured or dead wildlife to the CLEO office at (910) 451-5226.

e. The removal, destruction, injury, or killing of any plant aboard the installation, is prohibited except as specifically authorized.

f. The polluting of any waterway within the installation by dumping oil, acids, poisons, detergents or other pollutants is prohibited. The placement of any trees, limbs, weir, concrete, or other debris in any waterway is also prohibited.

g. Trees marked with a solid blue painted ring are designated as red-cockaded woodpecker cavity trees. Physical contact with marked cavity trees is prohibited. Additionally, the duration and frequency of recreational activities occurring within 50 feet of a marked tree should be kept to a minimum.

h. The use or possession of metal detectors is prohibited on any portion of the Installation.

i. The littering, dumping, or disposing of any kind of material, including lawn debris, aboard the Installation is prohibited.

j. Camping is permitted at designated camp sites only. Contact Marine Corps Community Services (MCCS) at (910) 451-1440 for more information. Camping is prohibited outside of the designated camping areas.

15. Beach Driving Regulations

a. Beach access is limited to foot travel only from designated entry points unless you acquire a beach driving permit. A Beach Driving Permit (decal) is required to gain access to the beach for off road access. Decals can be acquired at the CLEO at building SAW-400.

b. The authorization of vehicle use within the E-Training Area of Onslow Beach is intended to provide a means of allowing users to access remote portions of Onslow Beach beyond the designated recreational beach in order to perform authorized activities. This authorization is not intended to create a recreational 4x4 driving area within the "EB" training area.

c. Certain areas of Onslow Beach are seasonally closed to public access to protect endangered species; obey all posted signs. Avoid posted shorebird nesting areas.

d. Climbing or walking on the sand dunes is prohibited.

e. Entering military test sites or any other areas specifically posted to prevent access is prohibited.

f. Walking on or removing any vegetation (including sea oats) is prohibited.

g. Fires and open flames are prohibited on Onslow Beach.

h. Glass Containers are prohibited on Onslow Beach.

i. Pets are only allowed at designated areas and must be on a leash (no longer than 10 feet) at all times. You must clean up after your pet(s).

j. Refer to reference (i) for additional regulations regarding driving at Onslow Beach.

16. Fishing Regulations

a. In addition to the specific regulations listed below, fishing in ponds and inland waters will be conducted pursuant to reference (q).

b. Individuals using the Installation to participate in salt water fishing activities including clamming, oystering, fishing, shrimping, net fishing, and crabbing in coastal fishing waters, shall comply with reference (o).

c. <u>Fishing Areas</u>. All creeks, streams, rivers, and ponds within areas open to outdoor recreation are open to fishing.

d. <u>Managed Fishing Ponds</u>. The Land and Wildlife Resources Section on MCB CAMLEJ manages a series of fishing ponds available for recreational purposes. Level of management at each pond may vary

annually. The fish pond map can be obtained at the MCB CAMLEJ CLEO office.

e. <u>Managed Pond Regulations</u>. Periodically, ponds may be temporarily closed, be designated "catch and release," or have other restrictions for safety, fishery management, or vegetation control purposes. Abide by all signs posted at individual ponds.

(1) Hook and line, and rod and reel are the only lawful methods of take.

(2) Cast nests, trotlines, and set-hooks are prohibited.

(3) It is prohibited to use live fish as bait or release any species of fish into managed ponds, except fish caught from the respective pond or by biologists stocking the pond.

(4) Only natural bait (e.g., crickets, shrimp, worms, cut bait) and artificial bait may be used. Minnows are prohibited.

(5) Spading and digging for bait along shorelines of ponds are prohibited.

(6) The only authorized watercraft is row or paddle boats and canoes, with or without battery-operated trolling motors.

f. <u>Required Permits and Licenses</u>. An installation fishing permit and a NC Inland Fishing license is required to fish in the managed ponds. For all other areas the appropriate NC state fishing license is required.

17. Boat Launch Regulations

a. A Boat Launch Permit is required for authorized personnel to launch boats (including kayaks, canoes, and other non-motorized vessels) from ramps and launch sites within training (hunting) areas. Access to boat launches is contingent upon military training requirements. A boat launch permit can be obtained through the MCB CAMLEJ CLEO office

b. Boat launch permits are not required for Gottschalk, Courthouse Bay or MCAS New River Marinas.

c. Boat launch permits shall be issued only to individuals for vehicles they personally own. Permits are not transferable as to persons or vehicles. The permittee or their dependent must be present when the permitted vehicle is on installation property.

d. The permittee is responsible for security of personal property and safety and conduct of all persons entering the installation under the authority of his/her permit. Permittees and their guests who are charged with violating installation, NC or Federal wildlife laws while launched from installation property may have their permit revoked for not less than one year.

e. Vehicles and boat trailers will not be parked where they will interfere with launching and loading boats.

18. Firewood Collection. Firewood collectors shall:

a. Have the firewood permit and valid identification in their possession while engaged in firewood cutting and cut firewood only in authorized areas.

b. Be 16 years of age or older to operate a chainsaw for cutting firewood. Persons under the age of 16 may collect and load firewood under the direct supervision of a permitted guardian.

c. Only collect non-marketable timber such as downed trees resulting from timber harvest activities, training area maintenance, road construction, power line maintenance, storms, etc. Cutting or removal of any timber or timber products, other than downed trees described above, constitutes destruction or theft of government property.

d. Collect firewood for personal use only. Firewood is not to be sold.

19. Trapping

a. In addition to the specific regulations listed below, trapping will be in accordance with reference (q).

b. Requirements

(1) Prior to setting trap lines, trappers will provide the CLEO office with the following: (1) map of trap line, (2) number and size of traps to be used, (3) start and stop dates setting/running trap line.

(2) Trappers may use a .22 caliber pistol to dispatch lawfully trapped fur bearing animals.

(3) All steel-jawed traps set in the BOW-4 and BOW-5 sectors shall be positioned so each trap is submerged in water at all times.

(4) Transport or sale of live animals trapped on the Installation is not authorized.

(5) All trapping harvest must be reported in the electronic tracking system.

20. Dog Possession and Use

a. <u>General Dog Possession</u>. All general dog possession regulations apply to non-hunting and hunting dogs alike (unless otherwise noted). See reference (p) for other installation rules regarding domestic animals.

(1) All dogs and cats that reside on the installation must be registered with the Domestic Animal Control Office and up-to-date on all required vaccinations.

(2) Dog owners are responsible for damage or injury to property, people, and public buildings caused by their animals.

(3) Domestic animals are not permitted to run free (off-leash or at-large) anywhere on the installation.

b. <u>Hunting Dog Possession</u>

(1) Hunting dogs not permanently located aboard the Installation need not be registered; however, certificates of vaccination must be provided to the MCB CAMLEJ CLEO.

(2) Hunting dogs are the only animals permitted to run offleash. Hunting dogs are permitted to be off-leash in designated hunting areas during hunting season or in areas designated for dog training.

(3) Removal of any tracking or identification collar from any dog is unlawful.

c. Hunting Dog Use

(1) Individual hunters will not be permitted to use dogs while hunting deer, bear, turkey, or coyote.

(2) Hunting deer with dogs is authorized on organized hunts only.

(3) The use of dogs is permitted to hunt migratory/upland game birds, rabbit, squirrel, raccoon, and opossum during the designated season for each species.

(4) Persons are ineligible to be a dog handler (or assistant) if they have been convicted of violating an installation order, state

of NC wildlife regulation, or Federal wildlife regulation within the previous three years or have had multiple convictions.

d. Dog_Handlers will:

(1) Adhere to state, Federal, and installation regulations pertaining to hunting.

(2) Not enter impact or restricted areas, or areas other than the areas assigned on organized hunting dates.

(3) Be at least 21 years of age and their assistants, at least 18 years of age.

(4) Have at least one full season's active experience with organized hunting aboard the installation, at any level (i.e., stander, squad leader, assistant huntmaster, etc.).

(5) Be required to execute a Waiver of Liability, Assumption of Risk Agreement, and Certificate of Understanding.

(6) Sign the check station log book for dog retrieval after an organized hunt has been secured. All dog handlers must be secured from retrieving dogs, sign out on the log book, and leave the installation by 2100.

e. <u>Training Hunting Dogs</u>. Participation requires a NC state hunting license and an installation Hunting Permit.

(1) Training deer or bear hunting dogs is prohibited.

(2) Bird and small game dog training is authorized in areas designated for hunting and outside of the closed season for that species.

(3) Trainers must open a hunting session and close the session upon leaving the field.

(4) With the exception of domestically raised waterfowl or game birds, no animals (dead or alive) will be used.

21. Hunting Regulations

a. In addition to the specific regulations listed below, hunting will be in accordance with reference (q).

b. <u>Hunter Ethics and Safety</u>

(1) All hunters are accountable for observing all reasonable and necessary safety precautions.

(2) Intentional disruption, interference, intrusion, harassment, or foiling the success of another hunter is prohibited.

(3) Skinning and processing harvested game animals at the check stations is prohibited. Processing of game is allowed at the John A. Lejeune Rod and Gun Club (Building 1933/S1976).

(4) No persons will hunt while consuming, using, or under the influence of any intoxicating substance.

(5) Transporting or possessing firearms in a motor vehicle on the installation will be in accordance with reference (f). An unloaded firearm is one with all ammunition removed. Note: muzzle loading rifles are considered safe for transport when the firing mechanism is removed.

(6) Firearms may not be discharged in a negligent, careless, or reckless manner.

(7) Shooting at signs, into water, at solid objects, trees, structures, vehicles, or any government property is prohibited.

(8) Target shooting or sighting in of firearms is not authorized on the installation except at authorized ranges.

(9) It is recommended that anyone hunting from an elevated position utilize a safety harness.

(10) Jump shooting or driving game out to one or more standers by an individual or a group of hunters is prohibited.

(11) Hunters moving on the ground afoot 1.5 hours before and after legal shooting hours will display a white light.

c. <u>Hunter (blaze) Orange</u>. All hunters must wear an outer cap (or hat) and an outer, upper vest (or garment) of solid hunter (blaze) orange color.

(1) Material must be visible and unobstructed on both the front and back of the upper torso. Small insignias and non-hunter orange hat bills that do not substantially interfere with the visibility of the hunter orange are authorized.

(2) When items like tree stands are carried by hunters in a manner that the object carried obscures or diminishes the visibility

of the hunter's orange apparel, the object must be equipped with hunter orange to compensate.

(3) Dove and waterfowl hunters are only required to wear orange while walking through hunting areas during deer gun season.

(4) Wild turkey hunters are not required to wear orange during the spring turkey season.

(5) Trappers and firewood cutters must wear an outer cap (or hat) or an outer, upper vest (or garment) of solid hunter (blaze) orange color visible and unobstructed during the gun season for deer.

d. <u>Tree Stands/Blinds</u>. To prevent possible loss or damage, stands/blinds should be removed when not in use. The Installation is not responsible for stands/blinds left unattended.

(1) Any stands or blinds established for the purpose of hunting shall not have exclusive use rights.

(2) Threaded "screw-in" tree steps and portable stands/blinds are authorized but must be removed at the completion of the hunting season.

(3) Driving a metal object into any tree, hunting from a tree where a metal object has been driven, or the construction and/or use of permanent tree stands is prohibited.

e. <u>Bait Restrictions</u>. Lawful bait products and methods for baiting deer and bear, as described in the NC Regulations found in reference (q), are permitted in the Bow-Only hunting areas on the Installation.

(1) Any bait site established for the purpose of hunting shall not have exclusive use rights.

(2) Automatic feeders of any type are prohibited.

f. <u>Check Station</u>. Hunters are required to report all big game harvested at one of three installation check stations (Mainside - CLEO Office, Verona - Verona Loop Road, MCAS NR - CLEO Office). Important hunting and harvest information is posted at the installation check stations. Refer to Electronic Conservation Tracking System and Harvest Reporting sections for additional information.

g. <u>Hunting Weapon Possession</u>. Possession of legal hunting weapons is permitted only during designated hunting seasons in the authorized hunting zones and while in transit to hunting zones.

h. Legal Hunting Weapon. Only 10-, 12-, 16-, 20-, 28-gauge, and 410-caliber shotguns with commercial loads or equivalent, archery equipment, and black-powder equipment will be used for hunting on the Installation. Use of breech-loading rifles (including .22 caliber), over and under rifle/shotgun combinations of any type, and pistols for hunting is prohibited. Refer to each season section for a list of what device is legal to harvest specific game.

i. Daily/Season Bag Limits

(1) Bag limits for the Installation match those described in reference (q) for each season.

(2) Land and Wildlife Resources Section (LWRS) is authorized to set seasons/bag limits and other harvest restrictions that differ from those set by the state of NC if necessary to ensure the proper management of wild game populations on the installation.

j. Legal Access Hours. Hunters are not permitted in any area prior to or later than 1.5 hours before/after legal shooting time, except individual hunters when participating in night hunts for raccoon or opossum and hunters tracking wounded game. See reference (q) for legal shooting time specifications for each species.

(1) When tracking game later than 1.5 hours after legal shooting time, the hunter must mark the "tracking" box within their current open session.

(2) A hunter who has a harvested bear or deer in their possession by the end of legal shooting time but will not be able to return to the check station on time, may call (910) 451-5226 for an extension. The hunter must leave their name, permit number, phone number and time of return.

(3) Failure to check-in within 1.5 hours after legal shooting time on the day for which the pass was issued will result in the suspension of hunter privileges for seven days upon first offense, for 30 days upon second offense, and appearance before the Conservation Hearings Officer for third offense.

k. <u>Restricted Areas</u>. Entering any closed or restricted area for outdoor recreational purposes, to include hunting, is prohibited.

(1) Hunters may access locked gates when the area is open for hunting and a gate key has been obtained from the MCB CAMLEJ CLEO.

(2) When an area is reserved for organized deer hunts, only members of the organized hunt shall be permitted within the assigned area. No other person or unit personnel will enter the area.

(3) No firearm hunting, including shotgun and black-powder, shall be permitted within 200 yards and no archery hunting shall be permitted within 100 yards of any inhabited camping area, barracks, quarters, housing, primary road, landing field, stable, school, storeroom, supply or storage area, golf course, the Naval Medical Center, or in areas where troops are training, unless otherwise permitted.

(4) Hunters are not authorized to hunt from or within any range proper complex, Tactical Landing Zone (TLZ), impact area, runway, training facility/complex (classroom, tower, and road network), or inside building.

1. <u>Sunday Hunting</u>. Hunting on Sunday within the Installation boundary is allowed. Waterfowl hunting is not permitted.

m. <u>Scouting</u>. Scouting is the study and surveillance of wildlife movement and habits only. Calling, luring, attracting with scents or sounds, flushing, chasing, or any overt action greater than surveillance or locating signs of wildlife movement will be construed as "taking."

(1) Scouting is allowed in areas designated for hunting.

(2) Scouting will only be conducted during daylight hours and is contingent on training requirements.

(3) No firearms or archery equipment of any kind will be carried while scouting, either in the vehicle or on person.

n. <u>Harvest Reporting</u>. All game taken shall be reported via the electronic conservation tracking system (or alternative system if electronic is unavailable). For big game (i.e., deer, bear, or turkey), individual hunters must return to one of the Installation check stations to report their harvest.

(1) All requested harvest information on the hunt pass must be completed by the hunter and placed in the Harvest Box located at an installation check station.

(2) All individual hunters must close their session and enter harvest information via electronic conservation tracking system.

(3) The following will be recorded per species:

(a) White-tailed Deer: sex, actual weight (live or dressed), and antler measurements for antlered deer. Additionally, hunter must remove lower jawbone (attach provided label) of deer and leave it in the provided refrigerator. Note: removal of the jawbone

Enclosure (1)

at the time of harvest reporting is not required, if the hunter is going to have the animal prepared by a taxidermist; however, providing the jawbone after the taxidermist has processed the animal is required.

(b) Wild Turkey: sex, actual weight, beard length, and spur measurement.

(c) Black Bear: sex, actual weight (live or dressed), nose to tail length, wrist to shoulder length, neck measurement, chest measurement, and if it had any tags or a tattoo. We strongly encourage hunters that harvest a bear to remove an upper premolar tooth (located directly behind the upper canine tooth) and submit it to the NC Wildlife Resources Commission. The tooth is used to determine the age of the bear. For assistance with this process please contact the MCB CAMLEJ CLEO (910) 451-5226 or MCB CAMLEJ LWRS (910) 451-5063.

(4) Upon taking a deer, turkey, or bear and before moving the animal from the site of kill, the hunter must first validate the Big Game Harvest Report Card furnished with the NC Hunting License by cutting or punching out the crosshair symbol next to the appropriate authorization line that identifies the big game animal harvested.

(5) Hunters must register any harvested bear, deer, or turkey with NC wildlife Resources within 24 hours of the harvest and before it is skinned, dressed or dismembered. Registration options: call 800-I-GOT-ONE (800-446-8663) or online at www.ncwildlife.org.

(6) Small game species (including upland birds and waterfowl): species and number of each animal shall be reported on the hunting pass and in the electronic conservation tracking system.

o. Reporting Hunting Violations or Accidents

(1) Individuals who witness or have reason to believe a regulatory violation has occurred or is about to occur should report violators to proper authorities (installation CLEO or Provost Marshall Office (PMO)).

(2) Any person having knowledge that a hunting accident has occurred should attempt to get medical assistance in the form of a licensed emergency medical technician or other qualified persons by calling 911, as soon as practicable.

(3) The person requesting medical assistance should also contact the Installation CLEO or central dispatch to report the accident and provide all pertinent information.

22. Installation Hunting Seasons

a. <u>White-tailed Deer</u>. In addition to the specific regulations listed below, carefully review reference (q) for other laws and regulations related to deer hunting.

(1) Antler Definition Key

(a) Antlerless - deer with no antlers or has knobs or buttons completely covered by skin or velvet.

(b) Antlered - deer with visible antlers (bony structure) protruding through the skin.

(2) Archery

(a) Archery hunting is authorized in Hunt Zones 1, 2, 3, 4A, 4B, and all Bow-Only hunting areas during all open deer seasons.

(b) Archery hunting only has been established for areas: AA, AC, BB, BA-S, BOW1 through BOW14, DC, EA, EB, EC, E1, LD, LG, and RA.

(c) No type of firearm will be carried while archery hunting.

(d) Archery hunters should use discretion and caution when hunting near running/bicycle trails and be aware that people may be using the trail during hunting season.

(e) Refer to the NC regulations found in reference (q) for authorized equipment specifications.

(3) Black-powder

(a) Black-powder hunting is authorized in Hunt Zones 1, 2,3, 4A, and 4B in designated gun hunting areas during black-powder and gun deer seasons.

(b) Only muzzle-loading shotguns and muzzle-loading rifles (.40 caliber or larger) are authorized.

(4) Individual Gun Hunting

(a) Individual gun hunting is authorized in Hunt Zones 1,2, 3, 4A and 4B in designated gun hunting areas during gun deer season.

(b) Only conventional shotguns loaded with slugs may be used for individual gun deer hunting.

(c) Possession of buckshot while individually hunting deer is prohibited.

(5) <u>Antler Restriction Area</u>. Antler restrictions are implemented in various areas aboard MCB CAMLEJ in order to stratify age structure.

(a) All deer hunting in Hunt Zone 2 must comply with the antler restrictions.

(b) Antlered deer must be branched antlered (both beams) and possess a minimum of five total antler points.

(c) Antler points are considered legal for counting when they are one inch in length measured from the centerline of the main beam.

(d) Additional areas may be brought into or dropped from the antler restriction program as appropriate management necessitates.

(6) Organized Deer Hunting. The practice of hunting deer in an organized group involving the use of dogs.

(a) Scheduling will be the responsibility of LWRS in coordination with the AC/S, G-3/5. Hunt dates, number of hunts, and any other harvest restrictions will be set by LWRS.

(b) Oversight will be the responsibility of the Installation CLEO. An appropriate level of officers will be on-site during each hunt to properly manage the participants. The Chief CLEO is authorized to limit the number of participants and/or dogs allowed for each hunt if deemed necessary for safety reasons.

(c) Training requirements supersede all organized hunting activities. Scheduled hunts may be cancelled or participant numbers reduced based on training area availability. The Installation CLEO, in coordination with LWRS, will make the final determination if there is adequate area available.

(d) Only conventional shotguns loaded with buckshot may be used for organized deer hunting. Possession of slugs while organized deer hunting is prohibited. Muzzle-loading shotguns and rifles are not authorized for use in organized hunts.

(e) Participants must maintain a minimum distance of 175 yards or 1/10 mile between adjacent standers when direct line of sight is obscured (i.e., bend in road or dense vegetation).

(f) Only stand hunting or hunting from a fixed position is authorized for organized hunts.

(7) <u>Special Authority Hunts</u>. When determined to be necessary for game management, to protect human health and safety, or to provide hunt opportunities for persons with disabilities, special hunts may occur. Training requirements supersede all special authority hunting activities.

(a) Scheduling of these hunts will be the responsibility of the LWRS in coordination with the AC/S, G-3/5. Hunt dates, number of hunts, and any other restrictions will be set by LWRS.

(b) Hunts specifically for game management purposes may only be conducted in "no hunting," "exclusion," or "bow hunting" areas.

(c) Commanding Officer Invitational (COI) hunts may be authorized and coordinated as a Special Authority Hunt. COI hunts will be implemented within existing regulations (local, state, Federal, and installation) and in accordance with current MCB CAMLEJ wildlife management objectives and staff availability.

(d) Oversight will be the responsibility of the Installation CLEO. An appropriate level of officers will be on-site during each hunt to properly manage the participants. The Chief CLEO is authorized to limit the number of participants and/or dogs allowed for each hunt if deemed necessary for safety reasons.

(e) Off Road Vehicles (ORV) and specialized shooting equipment designed to assist participants with accessing areas and the acquisition of game may be authorized for some organized hunts.

(f) The antler restriction requirement for deer may be waived by the Head, Environmental Conservation Branch (ECON) for some hunts.

(8) John A. Lejeune Rod and Gun Club (LRGC)

(a) Members of the LRGC may participate in sanctioned recreational opportunities on MCB CAMLEJ.

(b) Any request from the LRGC for organized hunting opportunities will be submitted to LWRS via the clubs assigned MCCS Private Organizations Coordinator.

(c) LRGC organized hunts will be held to the rules and regulations described in the section on Organized Deer Hunting.

(9) <u>Huntmasters</u>. Each club participating in an organized deer hunt must assign a huntmaster, in writing, to the MCB CAMLEJ CLEO. Refer to Huntmaster Standards (Figure 6). For all organized hunts, the huntmaster (and their assistants) will:

(a) Be a licensed and authorized hunter per existing MCB CAMLEJ, state, and Federal regulations.

(b) Be thoroughly familiar with and will ensure complete compliance with Federal, state and MCB CAMLEJ laws regarding manner of taking wild animals and birds and the confines of MCB CAMLEJ.

(C) Direct a safe hunt and will be responsible for proper control, organization, and conduct of participants.

(d) Make contact with the MCB CAMLEJ CLEO before the close of business on the day prior to the organized hunt to obtain any updates.

(e) Provide a written roster to the MCB CAMLEJ CLEO of all personnel participating in the hunt at a date and time specified by the Chief CLEO.

(f) Verify that each hunter is eligible to hunt per existing regulations as established by NC General Statute and MCB CAMLEJ orders and policies.

(g) Report any and all violations of Federal, state and installation regulations to the MCB CAMLEJ CLEO, immediately.

(h) Will inform all persons (to include witnesses) involved in violations, hunting accidents, or other matters necessitating an investigation to remain at the scene until a law enforcement officer permits their departure.

(i) Notify the MCB CAMLEJ CLEO (910) 451-5226 within two hours after securing the hunt.

(j) Within 24 hours, provide to the MCB CAMLEJ CLEO the completed deer harvest data sheets and jaw bones collected from each deer harvested during the preceding hunt.

b. <u>Black Bear</u>. Carefully review reference (q) for other laws and regulations related to bear hunting, in addition to the specific regulations listed below:

(1) Individual hunting is authorized in Hunt Zones 1, 2, 3, 4A and 4B and Bow-Only areas during the designated bear season.

(2) Hunters are reminded that strict state and Federal regulations exist governing the use of bear and bear parts for commercial purposes.

c. <u>Migratory Game Birds</u>. Carefully review reference (q) for other laws and regulations related to waterfowl hunting, in addition to the specific regulations listed below:

(1) <u>Authorized Species</u>. Dove, Rails, Woodcock, Common Snipe, Crows, and Waterfowl (Ducks, Coots, Mergansers, Canada geese, and Brant).

(2) Methods

(a) Hunting is authorized in Hunt Zones 1, 2, 3, 4A and 4B during the designated seasons.

(b) Steel or nontoxic shot is required for waterfowl hunting.

(c) Dove hunters are required to remove their own spent shells within managed dove fields or when hunting from adjacent secondary roads.

d. <u>Small Game and Quail</u>. Carefully review reference (q) for other laws and regulations related to small game and upland bird hunting, in addition to the specific regulations listed below:

(1) <u>Authorized Species</u>. Raccoon, opossum, squirrel, rabbit, bobcat, coyote, nutria, striped skunk, fox, beaver, and quail.

(2) Methods

(a) Hunting is authorized in Hunt Zones 1, 2, 3, 4A and 4B during the designated seasons.

(b) For quail, shot size is restricted to #4 through #9.

(c) For small game, shot size is restricted to T through

#9.

(d) During deer gun season, slugs may be used for coyote and bobcat.

(e) Hunting raccoon and opossum between the hours of sunset and sunrise using artificial light is authorized.

e. <u>Spring Turkey</u>. Carefully review reference (q) for other laws and regulations related to turkey hunting, in addition to the specific regulations listed below:

(1) Hunting is authorized in Hunt Zones 1, 2, 3, 4A and 4B and Bow-Only areas during the designated turkey season.

(2) Use of dogs, live decoys, and electronic calls is prohibited.

(3) Only shotguns and archery equipment is authorized.

(4) Shot size is restricted to #4 or smaller and must be specifically manufactured for turkey hunting.

f. <u>Falconry</u>. Requests to use birds of prey for hunting will be approved on a case-by-case basis by the Head, ECON. Falconry will be conducted in accordance with all Federal, state, and installation regulations.

23. Enforcement of Regulations. The CG maintains the policy to use all legal means available to reduce violations of regulation identified or referenced in this Order. Violators shall be educated and disciplined, as appropriate, by the most effective means available.

a. <u>CLEO</u>. Primary enforcement and control of outdoor recreational users is the responsibility of the CLEO. The CLEO may: issue citations, apprehend violators, and stop vehicles on board the installation based on competent orders or reasonable belief that a violation of regulations has been committed.

(1) Failure to comply with any lawful order of the CLEO is prohibited.

(2) The CLEOs will conform to the standards and regulations set forth in this Order and the references with regards to the handling and disposition of offenders, search and seizure, use of force, and carrying weapons.

(3) If a wildlife enforcement situation warrants back-up, the PMO will assist the MCB CAMLEJ CLEO.

(4) The AC/S, G-F is the authority to request and coordinate law enforcement assistance from the NC Wildlife Resources Commission, the NC Marine Fisheries Commission, and the U.S. Fish and Wildlife Service.

(5) The Chief CLEO shall supervise and coordinate enforcement of all regulations including safe hunting practices at MCB CAMLEJ. The MCAS NR CLEO will supervise and coordinate enforcement of all regulations identified including safe hunting practices at MCAS NR.

(6) When notified of a hunting accident involving a firearm that occurs on MCB CAMLEJ, the MCB CAMLEJ CLEO will immediately inform ECON, G-F, and Physical Security that a hunting accident has occurred and will take appropriate action to secure the scene, persons, and physical evidence pertinent to the investigation. Primary investigative jurisdiction will be assumed by MCB CAMLEJ CLEO. Immediate notification will be given to Naval Criminal Investigative Service (NCIS) and PMO, Criminal Investigative Division (CID), and the MCB CAMLEJ CLEO shall keep G-F and Physical Security Division informed on the investigation. When notified of a hunting accident involving a firearm occurring at MCAS NR, the MCAS NR CLEO will immediately inform Director of MCAS NR Installation and Environment (I&E) that a hunting accident has occurred and will take appropriate action to secure the scene, persons, and physical evidence pertinent to the investigation. Primary investigative jurisdiction will be assumed by the MCAS NR CLEO. Immediate notification shall be given to NCIS, PMO and CID, and the MCAS NR CLEO shall keep the Director, I&E informed on the investigation.

(7) Within 48 hours of being notified of a hunting accident, the MCB CAMLEJ CLEO will submit a written report to G-F, of the incident, including all pertinent information and actions taken.

(8) Upon notification of an injury, the AC/S, G-F will recommend an investigation if the situation warrants.

(9) When a hunting accident results in death or when injury is such that death could result, the AC/S, G-F or their designee will immediately notify NCIS aboard MCB CAMLEJ, who will investigate the circumstances of the accident.

b. <u>Search of Motor Vehicles</u>. When there is reason to believe that a regulation was violated, and when there is reason to believe that evidence of a violation may be found in a suspected offender's motor vehicle or boat, authorized persons will request consent from the alleged violator to search the motor vehicle or boat. If consent is not given by the alleged offender, a search of the motor vehicle or boat will be conducted in accordance with reference (g).

c. <u>Processing of Violations</u>. Installation citations will be issued when any provision of these regulations is violated. A copy will be furnished to the violator. The remaining copy will be forwarded to the Base Conservation Hearings Officer or Central Violations Bureau (CVB), as appropriate.

(1) Upon receiving a report of violations off installation, administrative action will be processed by the Base Conservation Hearings Officer. When civil authorities suspend/revoke an individual's hunting, fishing, or trapping privileges for a specified time, the Base Conservation Hearings Officer will suspend said individual's hunting fishing, and trapping privileges aboard the installation for the same specified time.

(2) Military, retired military personnel, dependents and civilians involved in serious violations of state and Federal laws may be referred to the SAUSA for disposition. Violations of any state or Federal law may result in a fine issued by the CLEOs issued under forfeiture of collateral scheduled for MCIEAST properties. Fines levied by CLEOs will be paid within 30 days to the CVB. Fines not paid within 30 days may be issued a Notice to Appear in Federal Court. Failure to pay fines or appear in court on the date and time scheduled may result in a summons ordering appearance or the issuance of a warrant for arrest.

(3) Military citations related to violations may be issued only by the MCB CAMLEJ and MCAS NR CLEOs.

(4) A citation to appear before the Base Conservation Hearings Officer when issued by a CLEO will constitute a lawful order, the violation of which may result in administrative action before the Base Conservation Hearings Officer.

d. <u>Base Conservation Hearings Officer</u>. The administrative body responsible for carrying out the provisions of this Order and regulations within this ESOP.

(1) The Base Traffic Court Officer shall also serve as the Base Conservation Hearings Officer when hearing cases of alleged violations. The Base Conservation Hearings Officer will then be the body through which the CG may take administrative action against fish and wildlife violators.

(2) The Command Inspector General (CIG) shall provide administrative and clerical support to the Base Conservation Hearings Officer in order to record its actions and to perform other required administrative and clerical functions.

(3) The Base Conservation Hearings Officer shall establish the procedures for conducting hearings to ensure that any individuals appearing will be advised of the occasion for this appearance and the basis of and administrative action which may be taken.

(4) The Base Conservation Hearings Officer shall determine whether or not, and the extent to which, an alleged violation warrants

administrative action. It may consider any acts or conduct wherever they may occur of any person authorized to conduct activities. It will not be bound by any prior adjudication in its inquiry into the circumstances surrounding alleged acts or conduct that reasonably pertain to the safe operation of a firearm by the individual whose acts or conduct are challenged.

(5) Every case shall be fully and fairly heard. Persons appearing will be given an opportunity to present evidence and to make such statements as may be relevant to the circumstances of the case and the disposition thereof. Counsel may appear with any person.

(6) The Base Conservation Hearings Officer may suspend or revoke any permit when an individual is guilty of a violation.

(7) Hearings will be heard for all personnel having violations which occurred on the installation in the Base Traffic Court.

e. Enforcement Procedures

(1) No person will conduct activities within the jurisdiction of the Installation anytime their privileges have been suspended or revoked.

(2) If the Base Conservation Hearings Officer imposes a suspension period or revocation for violations, the individual immediately loses privileges unless a later period would provide a more appropriate or meaningful penalty. Suspensions or revocations imposed by civil courts are subject to enforcement aboard the Installation. Upon any subsequent revocation by the Conservation Hearings Officer, the individual will lose all privileges regulated or administered by the AC/S, G-F.

(3) The Base Conservation Hearings Officer will forward copies of citations and reports of action to the concerned individual's chain of command for information and appropriate action.

(4) <u>Rights of Appeal</u>. Any person whose privileges have been suspended or revoked has the right of appeal. When informed of suspensions or revocation, the individual will be informed of appeal rights. Persons will forward appeal (original and three copies) via the chain of command to the CIG, MCIEAST-MCB CAMLEJ. Appeals must be initiated within 10 working days from the date of notification of suspension or revocation action.

(5) Persons whose privileges have been revoked may reapply in writing via the chain of command to the Base Conservation Hearings Officer, after a lapse of 12 months and at three-month intervals thereafter, if desired.

(6) The Base Conservation Hearings Officer shall make appropriate entries of action taken and forward the findings to AC/S, G-F. Violation records against individuals will remain in effect for 36 months and will be officially filed in the CLEO Office. MCB CAMLEJ CLEO will coordinate with the PMO on all reports of criminal activity.

(7) <u>Authority of Commanding Officers</u>. Action taken by the Base Conservation Hearings Officer does not preclude, prohibit, or require commanding officers of their responsibility to take administrative/disciplinary action, as appropriate, against military personnel of their command or civilian employees under their supervision who are in violation.

(8) Violations of this Order or Federal and state regulations occurring on the installation will be acted upon by the Base Conservation Hearings Officer per Hunting Violations Table (Figure 7).




Figure 1.--Camp Lejeune Hunting and Fishing Map

Range Control and GF Departments have agreed to a program whereby security of GSRA and hunter access can be accomplished by allowing certain gates to be equipped with a Game Warden lock and a range control lock. <u>The security of GSRA facilities must not</u>. <u>be compromised</u>. Therefore, any hunter granted the trust of signing out a key for personal access must agree to the following:

-Only one key per hunter group will be given out. Hunter's license number, name, address, and phone number will be logged along with the key number.

-The key will not be transferred to any other person or used for any purpose except to allow access for hunting.

-The key will not be duplicated.

-Hunters who have been assigned a key will not deploy, go TAD, go on leave over 30 days, or PCS without returning the key. -Keys will be inventoried monthly during the hunting season on the first working Friday of the month by calling 451-5226 or going to Building Saw-400.

Keys can be inventoried one week prior to this date if you cannot make the designated date:

The GSRA key will be secured and returned to the Base CLEO immediately at the end of the season for which the key is signed out for, or the following date:

The hunter will agree to surrender his/her hunting permit if the key is not returned as required. A key will not be reissued to those who do not check their key in monthly.

A citation will be issued to those who do not return said key of government property in the agreed time.

HUNTMASTER STANDARDS

- Organized Deer Hunts. The Presidents, John A. Lejeune Rod and Gun Club and hunt clubs participating in the COI hunts, will provide annual huntmaster nominations to the Chief Conservation Law Enforcement Officer for approval.
- Specific Qualifications. Huntmasters will possess and assistant huntmasters will be trained towards the following qualifications:
 - a. Be a graduate of a hunter safety course sanctioned by the Hunter Safety Training Coordinator, North Carolina Wildlife Resources Commission, or the equivalent.
 - b. Be a member in good standing of the club in which they are representing and insured under the organization's liability and property damage insurance.
 - Have thorough knowledge of Base, State, and Federal hunting regulations.
 - d. Be a licensed hunter per existing Base, State, and Federal regulations.
 - e. Have a working knowledge of wildlife management.
 - f. Possess prior leadership experience in organized hunting for deer.
 - g. Be competent in land navigation and familiar with MCB, Camp Lejeune topography, all hunting areas, impact areas, danger areas, live-fire ranges, and restricted areas aboard Base.
 - h. Be on active duty status or retired from the U.S. Armed Forces (John A. Lejeune Rod & Gun Club Only).
 - i. Reside within 200 miles of Marine Corps Base, Camp Lejeune.
