

**BRIG CHASER CLASS
NOMINATION & QUALIFICATION SCREENING FORM**

Per the references and MCI-EAST MCB Lejeune Brig standards, service-members nominated to attend chaser escort training to serve as command prisoner escorts **MUST** meet the following requirements:

- ☐ Have served at least **15** months of active-duty service and have at least **12** months remaining on contract.
- ☐ Mature emotionally and mentally, with the ability to handle emergencies.
- ☐ No psychiatric disorders or in-service drug use.
- ☐ No history of alcohol abuse, or recovery programs within the last **36** months. Exceptions can be made **ONLY** by the Brig Training Staff.
- ☐ No Courts-Martial convictions or Non-Judicial Punishments within the last **48** months.
- ☐ No record of civil court convictions (except misdemeanor traffic violations).
- ☐ No disabilities that would prevent proper execution of duties. I.e. (No Light or Limited Duty)
- ☐ Must be within the Military Appearance Program standards and pass most recent physical fitness test of the individual's branch of service.
- ☐ No prior removal/revocation of escort status.
- ☐ Not identified as a witness/victim in a prisoner's court-martial related to the escort detail.
- ☐ Must not have failed to pass the escort proficiency test.
- ☐ Must not be a former prisoner or detainee.
- ☐ Must be screened for eligibility by a command representative of rank E-7 or above.

If requirements are not met. Service-members will be turned away. Non-negotiable.

Once nominated, individuals must attend a one-day Brig Escort Chaser Class, pass a proficiency test, sign an *Escort Standards of Conduct* form, and receive an escort identification card (NAVPERS 1640/18). Certification is **valid for 12 months** from course completion date.

Service members **will not** wear civilian attire to the class. The only Uniform-of-the-day that is authorized is the **camouflaged utilities**. Attendees shall bring their military ID and note taking gear. Check in time begins at **0645 until 0800, or until max capacity, 30 students. ATTENDEES ARRIVING AFTER 0800 WILL NOT BE ACCEPTED.** Check in will be located at 295 G Street Building 308 Camp Lejeune, NC (2nd Deck Classroom RM 2211). *See map chip on Brig webpage
