*MCIEAST Commanders may, at their discretion, grant a 72 hour liberty period immediately preceding or following the Veteran's Day holiday period.

- b. <u>Modifications</u>. MCIEAST Commanders are authorized to modify this routine for operational commitments, but are not authorized to exceed the specific duration. MCIEAST Commanders shall notify this headquarters of any modifications.
- c. <u>Risk Mitigation</u>. All hands are reminded that the judicious and effective use of annual leave is a good risk mitigation tool for those desiring to travel outside established liberty boundaries who desire to extend their stay over specific holidays.
- d. <u>Liberal Leave</u>. A liberal leave policy will be in effect for civilian personnel during these periods. Supervisors are encouraged to approve leave requests for civilian personnel in other than essential positions.
- e. Expectations. Professionalism by MCIEAST personnel is the expectation. MCIEAST-MCB CAMLEJ Department Heads and MCIEAST Commanders are reminded about personnel excellence, risk mitigation, the value to command, safety, COVID-10 restrictions and anti-terrorism/force protection precautions before travel and recreation begins. Upon completion of all holiday periods, all subordinate commands shall report to the Chief of Staff accountability of MCIEAST personnel.
