Subj: GAMBLING, BETTING, AND LOTTERIES

Ref: (a) DoD 5500.07-R Ch 7, "Joint Ethics Regulation (JER)," August 30, 1993

- (c) 18 U.S.C. §1955, "Prohibition of illegal gambling businesses"
- 1. <u>Situation</u>. This Order promulgates regulations concerning gambling, lotteries, pools and other games of chance for money or property, which are applicable to military and civilian personnel who live on, work on, or visit Marine Corps Base Camp Lejeune (MCB CAMLEJ) per references (a) and (b).
- 2. Cancellation. BO 5370.7E.
- 3. <u>Mission</u>. To provide policy in regards to regulating any gambling activity.
- a. <u>Summary of Revision</u>. This Order has been revised and should be thoroughly reviewed.
- b. <u>Punitive Effect</u>. This Order is intended to be directive in nature and implemented immediately. Violations of this Order by military personnel are punishable pursuant to Article 92 of the Uniform Code of Military Justice (UCMJ). A civilian who violates the provisions of this Order may be subject to prosecution per reference (c) and other applicable laws.

4. Execution

- a. Commander's Intent and Concept of Operations
- (1) <u>Commander's Intent</u>. To fully comply with this Order and its references.
- (2) <u>Concept of Operations</u>. It is the policy of this Command to not allow any form of gambling aboard MCB CAMLEJ in accordance with the references.

b. <u>Coordinating Instructions</u>

- (1) It is expressly prohibited for any person within the confines of MCB CAMLEJ to:
- (a) Conduct or participate in any gambling activity (including the operation of a gambling device), conduct a lottery or a pool, participate in a game of chance for money or property, or sell or purchase a number slip or ticket unless such participation has been authorized by the Commanding General per references (a) and (b).
- (b) Originate or participate in "Pyramid Clubs," "Chain Letter Clubs," or similar activities.
- (2) Subordinate and tenant commands are requested to promulgate the contents of this Order to personnel within their commands and post on unit bulletin boards.
- 5. <u>Administration and Logistics</u>. Point of contact for this Order is the Staff Judge Advocate, MCIEAST-MCB CAMLEJ, at DSN 751-2544, or commercial (910) 451-2544.

6. Command and Signal

- a. Command. This Order is effective the date signed.
- b. <u>Signal</u>. This Order is applicable to Headquarters, Marine Corps Installations East-MCB CAMLEJ, Headquarters and Support Battalion, Weapons Training Battalion and all tenant commands aboard MCB CAMLEJ.
