1. Purpose. To publish a revised 2023 and 2024 holiday observations liberty periods for Marine Corps Installations East-Marine Corps Base Camp Lejeune (MCIEAST-MCB CAMLEJ) General and Special Staff Departments and MCIEAST subordinate commands.

2. Cancellation. MCIEAST-MCB CAMLEJBul 1050 of 9 Aug 22.

3. Background. MCIEAST-MCB CAMLEJ Departments and MCIEAST subordinate commands will make every attempt to be in synchronization with the major tenant commands we support in alignment with references (a) through (c) and in accordance with the liberty limitations identified in references (d) and (e).

4. Action

a. The following liberty periods for Federal holidays will be observed by this command:

d. Liberal Leave. A liberal leave policy will be in effect for civilian personnel during these periods. Supervisors are encouraged to approve leave requests for civilian personnel in other than essential positions.


